QUESTION 1 BACKGROUND (20 MARKS)

- a) Outline the rationale and objectives behind your marketing activity.

TIP:

- a) *What were you trying to accomplish? You are encouraged to include measurable targets such as number of campaign partners, number of visitors, length of stay, regional dispersal, expenditure etc.*

QUESTION 2 RESEARCH (25 MARKS)

- a) Who were your target markets, why and what research did you use to identify them?

TIP:

- a) *This is a three-part question – make sure you answer a) who, b) why and c) what. Consider including geographic markets, demographics, psychographics, media preference, motivations for travel and purchasing patterns.*

QUESTION 3 CREATIVITY (25 MARKS)

- a) Describe the philosophy behind your creative strategy and demonstrate how you have integrated this philosophy into the actual creative.

TIP:

- a) *Include images that illustrate your creative approach and explain how they linked to what you wanted consumers to think about your destination.*

QUESTION 4 EXECUTION (20 MARKS)

a) Describe the marketing strategies used and detail the success and outcomes.

TIP:

a) Include all forms of marketing – print, digital, broadcast, PR etc. Include how your activity has positively impacted on the destination and/or stakeholders within your region as well as the individual outcomes of each strategy. This should be linked to the objectives identified in Question 1.

QUESTION 5 EVALUATION (10 MARKS)

a) Explain how you evaluated the success of your activities.

TIP:

a) Consider surveys, media monitoring, increase visitation etc.
